A person making a submission is entitled to request in the submission that they wish to appear in person, or to be represented by a person specified in the submission, at a meeting to be heard in support of that submission.

Any person requesting to appear in person or to be represented by a person specified in his or her submission will be notified of the day, time and place of the meeting of Council determined by the Council to hear submissions.

All submissions will be considered in accordance with section 223 of the Act.

Submitters should note that Council is required to make available for public inspection submissions received in accordance with section 223 for a period of 12 months.

Following consideration of submissions, Council will determine upon the adoption of the Council Plan.

TEMPORARY ROAD CLOSURE OF HILLVIEW ROAD AND HODGSONS LANE, BRIT BRIT

As part of Council's Capital Works Program 2016/17, culverts on Hillview Road and Hodgsons Lane, Brit Brit are to be replaced. The construction work will commence on **Tuesday, 2 May** and it is anticipated works will be complete by **12 May**, weather permitting.

Throughout the duration of works Hillview Road (from Gilberts Road to Hodgsons Lane) will be temporarily closed from **2 to 3 May** and Hodgsons Lane (from Coleraine-Balmoral Road to Hillview Road) will be temporarily closed from **4 to 5 May**. Local access will be provided for surrounding properties; however, there will be a period of time when vehicles access will not be available across the culvert.
