

OPERATIONS OF OUTDOOR POOLS

PURPOSE

This policy outlines the service levels for the operations of Southern Grampians Outdoor Pools.

DEFINITIONS

Council means Southern Grampians Shire Council.

APPLICATION AND SCOPE

This Policy applies to the Southern Grampians Shire Council's five outdoor pools.

Council is legally responsible for the management of Council five outdoor pools.

GENERAL PROVISIONS

SERVICE LEVELS

Heated Pools are in Hamilton, Balmoral, Coleraine, and Dunkeld, with Penshurst being an unheated pool.

1. Hamilton Olympic Swimming Pool will open the first weekend in November and all other Southern Grampians pools will open the first Saturday in December.
2. All pools will close on the long weekend in March, with discretion to extend beyond the long weekend dependant on temperature (where temperature is above 35 degrees Celsius) and lifeguard availability.
3. Pools will be opened from 3:00pm to 7:00pm seven days a week, with the following exceptions:
 - Pools will be closed when the air temperature forecast by the Bureau of Meteorology at 4:00pm for the next day is less than 23 degrees Celsius.
 - During January when the air temperature forecast by the Bureau of Meteorology at 4:00pm for the next day is more than 35 degrees Celsius all pools will open 12.00pm to 7:00pm.
 - On weekends during February through to the March Long weekend when the air temperature forecast by the Bureau of Meteorology at 4:00pm for the next day is more than 35 degrees Celsius all pools will open 12.00pm to 7:00pm.

Note: The air temperature forecast by the Bureau of Meteorology will be specific to the location of the swimming pool.

4. Supervised early morning swimming will be offered regardless of temperature at Hamilton and Coleraine two mornings a week.
5. Community or Sporting groups can request special use of the pools outside these dedicated service levels during the nominated season, but a fully accredited lifeguard must be on site at all times.
6. All outdoor pools will be closed on days determined to be Catastrophic Fire Danger Rating.

LIFEGUARD AVAILABILITY - EXEMPTION

The implementation of this policy is dependent on the availability of qualified Lifeguards in accordance with the Royal Life Saving Guidelines for Safe Pool Operations.

This Policy came into operation on 25 October 2017 and was subsequently reviewed:
