Application for Extension of Time for a Planning Permit

In Accordance with Section 69 of the Planning & Environment Act 1987

- Before the permit expires or within 6 months afterwards, the owner or the occupier of the land to which it applies may ask the responsible authority for an extension of time.
- The owner or occupier of land to which a permit for a development applies may ask the responsible authority for an extension of time to complete the <u>development</u> or a stage of the <u>development</u> if
 - the request for an extension of time is made within 12 months after the permit expires; and
 - the development or stage started lawfully before the permit expired.
