

PHYSICAL DESCRIPTION:

The former Catholic Convent is a single storey symmetrical bluestone house with a gabled corrugated iron roof. The windows are twelve-paned, double-hung sashes. It has been extended in weatherboard at the rear, possibly replacing an earlier detached or semi-detached kitchen wing. A new verandah has been added at the front.

HISTORY:

J. C. Watson purchased the land on which the former convent stands from the Crown on 15th December 1857. He bought allotments 1 and 2 of section 7. At some time in the early twentieth century Mrs. Chesswas, wife of the storekeeper, James George Chesswas owned the property. However, the family lived at 83 Bell Street, the former Common School, opposite their store. The Chesswas family appears to have moved from Richmond to Penshurst in 1871 when James Chesswas Senior first appears in the ratebooks described as a carrier. At that stage they rented a house owned by Michael Hoare (SMRRB, 1871, 283). Mrs. J. G. Chesswas was the daughter of Alexander Black, who was an important early councillor, active in the community and the first pound keeper. James George Chesswas, along with Robert Aitken, acted as trustee for the Temperance Hall beside the former Catholic Convent.

According to the Mount Rouse and District Historical Society, the house was built in the 1880s. From 1945 to 1975 the Sisters of Mercy nuns occupied it. The nuns taught at the nearby St Joseph's Catholic school. After 1975 it became a private residence.

STATEMENT OF SIGNIFICANCE:

What is significant?

The single storey bluestone house at 73 Watton Street, Penshurst was built in about 1880. By the early twentieth century, the Chesswas family owned it. They had moved to Penshurst from Richmond in 1871 and became storekeepers, living in the former National School opposite their store in Bell Street. In 1945, the Sisters of Mercy purchased the house and established it as a convent. The nuns taught at the St Joseph's primary school in Martin Street until 1975. Since then, the house has been owned and occupied by the O'Brien family. It is in good condition and retains a fair degree of integrity.

How is it significant?

The former Catholic convent at 73 Watton Street, Penshurst is of historical significance to the Southern Grampians Shire and to the township of Penshurst.

Why is it significant?

The former convent is of historical significance generally as a residence in the township and specifically for its
